Hong Kong Chronicles eBook's Terms and Conditions of Use

1. 《香港志》電子書只限用於研究或教學用途。

Hong Kong Chronicles eBook is available for research or teaching purposes only.

2. 香港地方志中心有限公司（「本中心」）保留《香港志》電子書授權的最終決定權。

Hong Kong Chronicles Institute Limited ("HKCI") reserves the final decision to accredit the use of *Hong Kong Chronicles* eBook.

3. 如需列印《香港志》電子書的內容，列印篇幅不可超過著作內容的 20%（包括但不限於圖、表、文字等）。列印之電子書只供申請人作研究或教學之用。未經本中心同意，不能公開發布，包括但不限於媒體及印刷品。

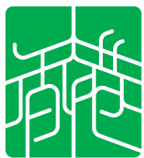
